

Study Overview

To better understand the value-added economic impacts of defense-related spending flowing into and throughout the Commonwealth, the Secretary of Veterans and Defense Affairs, in 2020, commissioned a comprehensive economic impact assessment. This 2022 factbook provides the first of future biannual updates to that assessment.

This updated study was conducted using the same methods of the original study so as to provide a true comparison between 2020 and 2022. The study examined the most recent federal defense-related spending data which included Department of Defense (DoD) and Homeland Security (DHS) contracts, annual compensation of all active duty and civilian personnel, National Guardsmen, and Reservists assigned to Virginia installations, and the monetary benefits provided to the veterans and military retirees who call Virginia home.

The study utilizes the IMPLAN input-output model to trace the multiplier effect associated with direct defense-related spending. As its name implies, the multiplier effect tracks how direct spending ripples (or multiplies) through the state economy generating additional spending effects, often called indirect and induced impacts. The impacts summarized in this factbook are jobs and Gross Regional Product. This method was purposefully chosen to accurately portray the value-added impact to the Commonwealth's economy.




Impacts by the Numbers

Concentration of Military Retirees to Veterans



Virginia boasts the highest concentration of military retirees in the nation, and increased from 2018 to double the national average. This is important to the Commonwealth because retirees provide leadership in their communities, contribute to a highly skilled and well compensated workforce, and generate additional economic impacts across the Commonwealth.





The western most region of Virginia has a variety of defenserelated impact. In 2021, Region 1 saw \$1.75 billion in direct defense-related spending, mostly in pensions and medical care. Defense contracts accounted for over half a billion dollars and were mostly within the ammunitions manufacturing and facilities support services industries. Many of these contracts were executed by BAE Systems, a major national defense contractor which oversees operations at the Radford Army Ammunition Plant. Having robust contract opportunities is a leading reason why the region sees over 17,000 jobs influenced by defense-industry spending. All told, Region 1 can attribute \$1.2 billion in economic impact (approximately 3% of the total region economy) to defense-related spending.

The Radford Army Ammunition Plant totals over 6,000 acres spread across Montgomery County and Pulaski County and is located immediately adjacent to the City of Radford. The plant was built in the 1940s to support the war effort and, since then, has played an important role in every American conflict. Today the Radford Plant is the core propellant-manufacturing facility for the Department of Defense, capable of producing mass quantities of solvent and solvent-less propellants to support direct fire, indirect fire, and rocket applications. In July, 2022 BAE Systems received a \$1.29 billion contract modification from the U.S. Army to continue operations onsite, ensuring a bright future for the plant.

Region 2 is home to the Fort Pickett Army National Guard Maneuver Training Center (MTC), a state of the art facility which provides training for national guard Soldiers from across the nation as well as various federal and state law enforcement entities. In 2020, the region received over \$510 million in direct defenserelated spending, mostly as payments in support of personnel compensation and veteran and military retirees. This spending showed an increase of over 14% from 2018; evidence that the region's ties to the defense industry are only growing. Combined, defense-related activities supported over 5,600 total jobs (direct, indirect, or induced) and \$390 million dollars in total economic impacts consisting of roughly 3% of the region economy.

Fort Pickett Army National Guard Maneuver Training Center (MTC) totals over 40,000 acres primarily spread across Brunswick, Nottoway, and Dinwiddie Counties. The MTC is an Army National Guard training facility serving soldiers from regional National Guard units, active military units from other installations, and soldiers from all branches of the military. The highlight of this installation is a 832-acre Multi-Purpose Range Complex (MPRC) which underwent extensive renovations and improvements throughout 2020. The MPRC is one of only four such facilities on the east coast and can accommodate live fire maneuvers from a wide variety of military systems including Bradley Fighting Vehicles, Abrams Main Battle Tanks, amphibious assault vehicles, and rotary wing aircraft. Fort Pickett also regularly hosts training from various non-DoD organization such as the US Marshal Service, FBI, ATF, and Civil Air Patrol.

This region is home to two prominent military installations: Fort Lee and Defense Supply Center Richmond, which includes DLA Aviation, as well as the Hunter Holmes McGuire VA Medical Center. In 2021, the region received over \$4.5 billion in direct defense spending with compensation at these installations accounting for the majority of that spending. Additionally, the nearly 87,000 veterans and military retirees residing in Region 4 received \$1.42 B in transfer payments – over 30% of all defense-related spending.

Private sector defense contracts performed in the region constituted an additional 16% (\$739.8 M) of spending. The medical equipment and supplies wholesalers industry accounted for the most significant portion of these contracts while additional notable private sector defense activities occurred in software publishing, custom computer programming & design services, other computer related services, facilities support services, and all other professional, scientific, and technical services industries. Combined, defense-related activities supported over 54,000 total jobs (direct, indirect, induced), generated over \$5.7 billion in gross regional product, and were responsible for roughly 6% of the region's economy.

Defense Supply Center Richmond (DSCR) is the headquarters of Defense Logistics Agency (DLA) Aviation and consists of over 640 acres and 5.1 million square feet of covered /uncovered storage space utilized in their core mission to supply products in direct support of over 1,800 major DoD weapons systems across all services. In addition to this mission, DSCR is responsible for the storage of approximately 1,200 tactical vehicles for United States foreign military sales and for managing the storage and handling of all DoD ozone depleting substances. DSCR is also home to the 102,000 square foot Virginia National Guard Bob Slaughter Headquarters facility that opened in May 2018. This facility houses the Adjutant General, the Virginia National Guard Joint Staff, and Air National Guard staff.

Fort Lee is home to the Combined Arms Support Command (CASCOM) and the Sustainment Center of Excellence which includes the Army's Quartermaster, Ordnance, and Transportation schools. Approximately one third of all Army soldiers will either train or be stationed at Fort Lee during their careers and multiple Marine and Navy logistics training programs also take place at Fort Lee under CASCOM administration. A number of other tenant units also call Fort Lee home including the headquarters for the Defense Contract Management Agency and the Defense Commissary Agency, which is responsible for operating a worldwide chain of commissaries that provide groceries to military personnel, retirees, and their families in a safe and secure shopping environment. Fort Lee also hosts the US Army Quartermaster Museum and the US Army Women's Museum. *Pending approval by Congress, the DoD Naming Commission recommended Fort Lee be redesignated as Fort Greag - Adams

he communities that make-up Region 4 collectively support 19 military installations (including two joint bases) which represent five of the military services (Air Force, Army, Coast Guard, Marine Corps, and Navy). Region 4 is the only place in the country that hosts four different 4-star commands, including the Air Force's Air Combat Command, the Army's Training and Doctrine Command, the Navy's Fleet Forces Command, and NATO's Allied Command Transformation, which is also the only NATO headquarters located on U.S. soil. This region received over \$32.5 billion in defense-related spending, with 46% (\$15.2 B) going toward military and civilian personnel and another 41% (\$13.43 B) in defense contracts. Because of this large active military presence, veterans and military retirees residing in Region 4 drive a smaller share of the military's overall impact in the region as opposed to the previously discussed regions. Known for its maritime workforce, Region 4 draws on skilled tradesmen and a highly technical workforce to perform shipbuilding and repair operations, which account for the largest portion of the defenserelated contracts in this region. These same contracts support a significant number of the nearly 332,000 jobs (direct, indirect, induced) impacted by the defense industry in Region 4.

Located on the eastern shore of Virginia, Surface Combat Systems Center (SCSC) Wallops Island is home to a variety of unique and critical missions. Most prevalent of these is Naval Sea Systems Command which is responsible for providing highly technical engineering and training support to the fleet. SCSC Wallops Island is also co-located with the Mid Atlantic Regional Spaceport and Wallops flight Facility, managed by NASA and the Virginia Commercial Space Flight Authority. These facilities represent one of only five licensed spaceports in the United States and host assets from Space Force development projects, research aircraft, and unmanned aerial systems, to suborbital and orbital rockets. Another key partner at Wallops is NOAA. The NOAA Wallops Command and Data Acquisition Station is one of only two NOAA facilities in the world that monitor the satellites that collect vital weather data for the nation.

The City of Norfolk is home to Naval Station Norfolk, the largest Navy installation in the world and homeport to all of the Navy's aircraft carrier groups on the East Coast as well as five additional naval squadrons and 13 major shore commands. Naval Support Activity Hampton Roads, also in Norfolk, provides support to a number of fleet headquarters, including U.S. Fleet Forces Command, U.S. Marine Corps Forces Command, Naval Submarine Forces Atlantic, Naval Surface Forces Atlantic, and Naval Air Forces Atlantic. In addition, Norfolk is home to NATO's Allied Command Transformation Headquarters, the only NATO Headquarters organization located in the United States. The U.S. Army Corps of Engineers also maintains one of its district offices in Norfolk.

The City of Chesapeake is home to three particularly important assets which support Naval operations. Naval Auxiliary Landing Field (NALF) Fentress, under the operational control of Naval Air Station Oceana, supports day and night field carrier landing practice operations by the Navy and Marine Corps F/A-18 Hornets. The Hampton Roads Northwest Annex is home to the Relocatable Over the Horizon Radar (ROTHR) – a surveillance asset which supports Department of Homeland Security's drug surveillance efforts of the Caribbean basin and South America from Florida to Bolivia. St. Juliens Creek Annex provides a radartesting range as well as various administrative and warehousing facilities and light industrial shops for nearby Norfolk Naval Shipyard and other local naval activities.

ome to NSF Dahlgren and Fort A.P. Hill*, Region 5 attracted just over \$3.7 billion in defense-related spending in 2018. While personnel compensation constituted the largest share of spending (\$1.6 B), veterans and military retirees residing in the region received 27% (\$1 B) of the total spending in the region. The remaining \$1.08 billion flowed through regional defense contractors performing defense activities. Of these contractors, the engineering services and research and development industries generated the largest share of regional defense contracting work. Combined, the \$3.7 billion in defense-related spending supported nearly 35,500 total jobs (direct, indirect, induced) and over \$4 billion in Regional Economic Impact, accounting for 21% of the region's economy.



National Capital Region-Marine Corps Base Quantico (MCINCR-MCBQ) is a world-class, joint-service training installation encompassing nearly 59,000 acres that extends into Stafford County (Region 5), Prince William County (Region 6) and Fauquier County (Region 7). The installation is considered the "Crossroads of the Marine Corps" because its missions touch the furthest reaches of the Corps. Decisions made by the Training and Education Command, the Weapons Training Battalion, or any of the other two dozen tenant units at MCINCR-MCBQ impact Marines aboard ships, fighting global conflicts, or on guard duty at embassies across the world. Additionally, MCINCR-MCBQ contains the Marine Corps University which provides basic training for virtually all Marine officers and is the headquarters of the Marine Helicopter Squadron One, tasked with providing rapid transportation for the Presidents of the United States.

his region hosts several important Department of Defense assets, as well as national and strategic headquarters, including the Pentagon, Arlington National Cemetery, Joint Base Myer-Henderson Hall, Fort Belvoir, the National Guard Bureau, and parts of Marine Corps Installations National Capital Region-Marine Corps Base Quantico. Of the \$43.4 billion in direct defense-related spending received in 2020, 65% (\$28.5 B) flowed through defense contractors performing defense activities, with engineering services, computer systems design services, research and development, other computer-related services, management consulting services, and all other professional scientific and technical services making up more than 50% of defense contracts. Region 6's robust population of veterans and military retirees received about 8% (\$3.3 B) of defense-related spending in the form of pensions and other benefits. The remaining approximately 26% (\$11.6 B) of total spending went to military and civilian personnel compensation. When accounting for direct, indirect, and induced effects, the \$43.4 billion in direct spending supports roughly 409,500 jobs, generates \$54.5 billion in regional economic impact, and drives approximately 24% of the region's economy.

his region is home to Rivanna Station and the U.S. Army's Judge Advocate General's Legal Center and School located at the University of Virginia in Charlottesville. In 2020, the region received just over \$1.9 billion in direct defense-related spending. The region's veterans and military retirees received transfer and benefits payments accounted for roughly 43% (\$818.4 M) of these dollars, while 30% (\$530.4 M) went to personnel compensation and 26% (\$473.1 M)flowed through regional defense contractors. Contractors performed the vast majority of their contracts in the following industries: search, detection, navigation and nautical systems manufacturing, all other professional, scientific and technical services, engineering services, other computer-related services, computer systems design services, and research and development. In all, defense related spending supported roughly 20,000 total jobs (direct, indirect, induced), generated just over \$1.8 billion in gross regional product, and drove approximately 4% of the region's economy.

Virginia is for military members, their families, and veterans




